A motion was made by Downey and supported by Standel to accept the August 11th minutes as presented. Unanimous vote. Motion carried.

A motion was made by Standel and supported by Downey to approve Resolution 2021-04 Local Road System Funding Assistance Program Application 2022 to replace crossroad culverts that are failing. Roll Call vote: Downey-yes, Lauwers-yes, Standel-yes, Lewis-yes, McDonald-yes. Unanimous vote. Motion carried.
