November 9, 2016

Thomas Heele was present to express concerns with the neighbor having blight issues.

A motion was made by McDonald and supported by Downey to approve Ordinance #37 which changes the zoning for parcel #74-27-035-4001-101 from Light Industrial to Agriculture. Unanimous vote. Motion carried.

A motion was made by Libkie and supported by Standel to approve \$25,000 ditching project with the 2017 Local Road Funding Assistance Program Agreement with the county. Unanimous vote. Motion carried.

A motion was made by Standel and supported by Libkie to approve a culvert installation near 13530 Kaufman Road. Unanimous vote. Motion carried.

A motion was made by Downey and supported by Libkie to approve a license for Class C Used Vehicle Parts Dealer at 14930 Downey Road for the purpose of selling parts on vehicles that are towed into the lot to recoup the costs of nonpaid towing bills. Vehicles are not to be purchased for scrapping purposes. Unanimous vote. Motion carried.

A motion was made by Standel and supported by Libkie to have the zoning enforcer check 15082 Imlay City Road to make sure they are not living in the travel trailer. Unanimous vote. Motion carried.
