Regular Meeting  
June 12, 2019

Supervisor Lauwers called the meeting to order at 7:30 p.m. Michael Lauwers (Supervisor), Sheila McDonald (Clerk), Terry Geliske (Treasurer), Bruce Downey (Trustee) and Monica Stadel (Trustee) were present. Six guests was present.

A motion was made by Stadel and supported by Geliske to approve the May 8<sup>th</sup> meeting minutes and March 13<sup>th</sup> amended meeting minutes as presented. Unanimous vote. Motion approved.

Eduardo and Nancy DeJesus were present to express concerns with ducks being on their property from the neighbors on Burt Road.

Heidi Couto was present to address a concern the board had with a storage trailer being kept on the property. A motion was made by Stadel and supported by Downey to allow 3 months (9/11/19 meeting) to have the trailer removed. Unanimous vote. Motion carried.

Art Smith was present to inform the board that he is working on cleaning up his property on Bryce Road. Improvements have been made since the zoning enforcer first visited.

A motion was made by Downey and supported by Stadel to approve Resolution 2019-03 regarding the Cannis Drain. Geliske-yes, Stadel-yes, Lauwers-yes, Downey-yes, and McDonald-yes. Unanimous vote. Motion carried.

A motion was made by Stadel and supported by Downey to approve supplying the porta johns for Capac Days at a cost not to exceed \$500. Unanimous vote. Motion carried.

A motion was made by Stadel and supported by McDonald to approve the RESA Contract Agreement at a cost not to exceed \$8163. Unanimous vote. Motion carried.

A motion was made by Downey and supported by Stadel to deny the properties listed on the Foreclosure List for St. Clair County. Unanimous vote. Motion carried.

A motion was made by Stadel and supported by Geliske to approve the 2019 Park & Recreation Millage Distribution as presented. Unanimous vote. Motion carried.

**Building Department:** Report submitted. A motion was made by Stadel and supported by Downey to check into putting some kind of lien or stipulation for property that is being sold on Burt Road with a pole barn constructed before the residence. Unanimous vote. Motion carried.

**Capac Youth Sports Committee:** A motion was made by Stadel and supported by Downey to have the picnic tables that were ordered to be engraved with "Mussey Township" at an additional cost of \$400 for all of the tables. Unanimous vote. Motion carried.

**Cemetery Board:** The board would like to look into having someone straighten some of the headstones that are leaning in the cemeteries.

**Clerk's Report:** A motion was made by Downey and supported by Geliske to pay the June bills (General fund Ck #95776-95801, Fire Fund Ck# 8388-8419, and Bond Fund Ck#2477-2479) Unanimous vote. Motion carried.

Motion carried.
